Summary School Self-Evaluation Report

1. Introduction

Our school has its own context. There are 13 teachers and 138 pupils in the school. We have a number of programmes operating in the school including DEIS, HSCL, School Completion Programme, Lift-Off to Literacy, Maths Recovery, music, camogie. Our attendance levels are good and are improving every year. Our pupils' behaviour is excellent and they are a credit to the school and their families. Many of our activities have been curtailed because of the effects of Covid 19 in the past 18 months.

1.1 The focus of the evaluation

We undertook a school self-evaluation of teaching and learning during the year. We evaluated our school's Digital Strategy and took part in the Department of Education's Wellbeing Pilot.

This report summarises the strengths that were identified and the areas that have been prioritised for improvement.

2. Summary of school self-evaluation findings

We collected information from parents, pupils and teachers in preparing this report. We looked at the digital literacy of both staff and pupils.

We carried out questionnaires with pupils, staff and parents around the areas of wellbeing.

2.1 We found that our school has **strengths** in the following areas:

- We have a good IT infrastructure in our school. We have a set of 16 iPads for use in classrooms, bought by the Parents' Association. We have interactive whiteboards and laptops in all classrooms. We have a staff willing to do CPD and upgrade their skills.
- A huge majority of pupils in our school feel safe and well cared for.
- A huge majority of parents feel their children are well cared for and well taught in our school.
- Most teachers feel supported by management in the school and by their colleagues.

2.2 We have decided to prioritise the following areas for development:

- Teacher and Pupil IT skills this is laid out in detail in our Digital Strategies Plan, which is on our website.
- Pupil Voice children do not have a full understanding of pupil voice. This will be prioritised and ways in which pupil voice can be heard will be worked on in school – see Wellbeing Policy available on our website.
